Sound & Lighting

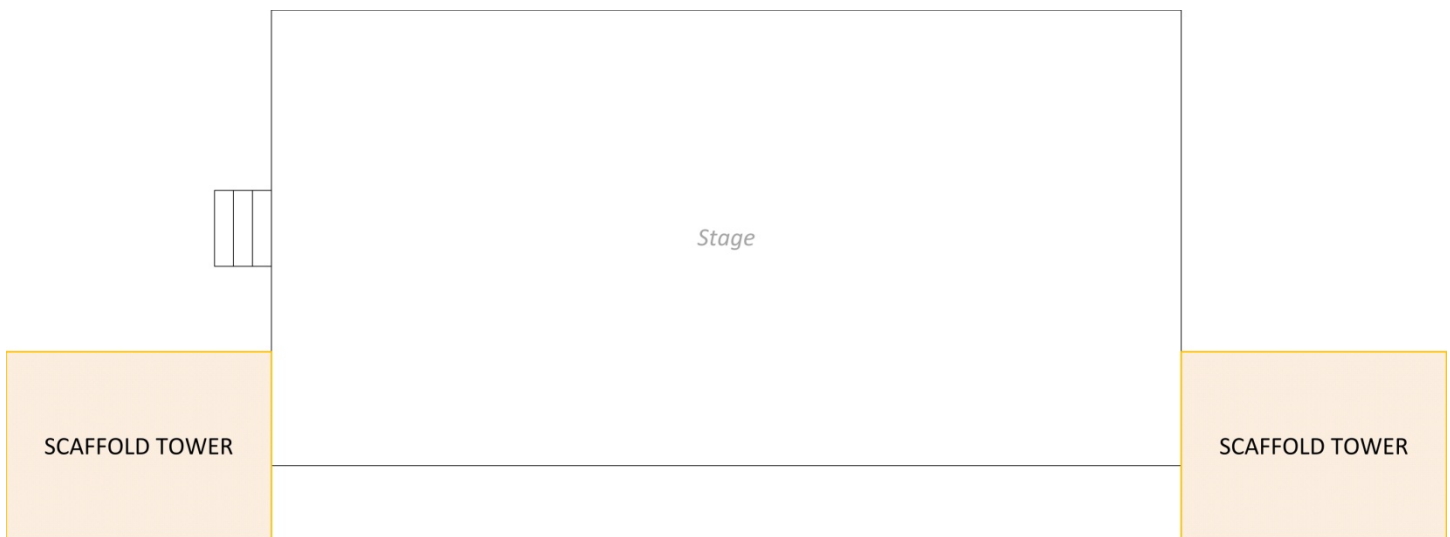

Stage Plot

Please roughly draw your preferred stage layout including placement of persons, instruments, microphones, DIs, monitors, etc. This will help ensure stage changes are as quick as possible.



Obligations

1. The Artist/Group agrees to provide entertainment as described above in this document.
2. The Artist/Group will provide all instruments and on-stage amplifiers required for the performance of music, but Valley Center Chamber of Commerce will provide all required sound-reinforcement and PA equipment, including stage monitors, and including an operator for all such equipment, at Valley Center Chamber of Commerce's sole expense. Valley Center Chamber of Commerce will provide all required lighting equipment, and an operator for all lighting equipment, at Valley Center Chamber of Commerce's sole expense. The Artist/Group will not be in breach of this Contract for failure to perform if Valley Center Chamber of Commerce-provided lighting or sound equipment fails to work properly, or if Valley Center Chamber of Commerce's equipment operator fails to set up or operate lighting or sound equipment properly.
3. The Artist/Group will be allowed to load out its equipment and to leave promptly upon completion of the performance. The Artist/Group will make all reasonable efforts not to be disruptive as other Artist(s)/Group(s) are performing.
4. Valley Center Chamber of Commerce is not responsible for protecting the Artist/Group's equipment and instruments from the elements.
5. Contracts cannot be canceled by the Valley Center Chamber of Commerce or the Artist(s)/Group(s), without a mutual written agreement.
6. Valley Center Chamber of Commerce and the Artist/Group shall be excused from their obligations detailed herein in the event of proven sickness, riot, strike, epidemic, act of God or any other legitimate condition or occurrence beyond their respective control.
7. Valley Center Chamber of Commerce reserves the right to cancel the performance or to delay the performance for a sufficient time to correct problems if in its sole discretion the performance area is inadequate or dangerous, and if weather conditions make performance dangerous or damaging to equipment.
8. If Artist/Group arrived and was prepared to play when canceled, full compensation will be due.
9. If cancellation is due to Artist/Group's failure to meet the terms of this Contract, then the agreed upon compensation will not be due.

Compensation:

Compensation will be based upon selection of Opening Act and Headlining Act performance times and dates.

Saturday Afternoon 11:00 am – 1:00 pm \$350.00, 1:30 pm – 3:30 pm \$400.00

Saturday Evening Opening Act 6:00 pm – 8:00 pm \$450.00, Headlining Act 8:00 – 11:00 pm \$ 850.00

Please have all information to the Chamber Office no later than March 30th, 2018 for consideration. The Chamber will notify selected Entertainers by June 30th, 2018 for scheduling.
